Stop The ReVenture Incinerator

A Charlotte company plans to build and operate a waste incinerator at the proposed ReVenture Park in the Catawba River District of Mecklenburg and Gaston counties. According to ReVenture project developers, the incinerator could burn wood scraps, garbage and sewage sludge in a 20 megawatt waste-to-energy plant.


The people pushing the proposal deny that it's an incinerator, but that's what it is.

Incinerators burn waste, release toxic air pollution and create toxic ash.

Calling it "biomass" or "gasification" does not make it safe.

Incinerators Are Bad Neighbors

BAD FOR THE ENVIRONMENT

With four ash ponds from coal-fired power plant on its banks, the Catawba-Wateree River is already the most endangered river in the United States. The ReVenture waste-to-energy incinerator would create more toxic ash.

BAD FOR PEOPLE

The North Carolina Academy of Family Physicians stated that burning biomass creates emissions of particulate matter that increase the risk of premature death, asthma, chronic bronchitis, and heart disease. They said:

This burning process also creates numerous byproducts, including nitrogen oxides and volatile organic compounds that increase smog and ozone, which are known to increase lung disease and mortality; sulfur dioxides which also



contribute to respiratory disease; arsenic which can increase the risk of cancer; mercury which can increase the risk of brain and kidney disease and affect the developing fetus; and dioxins which may increase the risk of cancer, heart disease, diabetes mellitus, developmental delays in children, neurotoxicity, and thyroid disease.³
